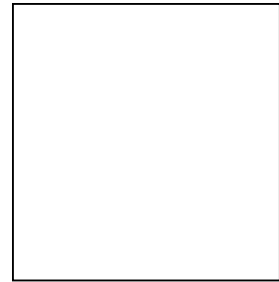

PVUN Limited, Patratu is a subsidiary of NTPC Limited in Joint Venture with Jharkhand Bijli Vitran Nigam Limited (JBVNL). We are constructing 3 x 800 MW power plant at Patratu. We are looking for General Duty Medical Officer (GDMO) who will be posted at our PSTPP Health Centre at Patratu. The details of the position are as below:

- A) QUALIFICATION: MBBS from recognized University/ Institution. [Qualification should be recognized by Medical Council of India]
- B) Experience: However, Preference will be given to experienced candidate; Experience of NTPC, subsidiary of NTPC or JV of NTPC is preferable.
- C) Pay & Emoluments – INR 1,23,000/-. In addition, rent free bachelor accommodation (subject to availability) or INR 2000/- as HRA will be paid. In addition to this, medical facility for self at PVUNL Hospital will be provided. (The rates are for prevailing pandemic situation and same shall be reviewed)

General Conditions

- 1) Only Indian Nationals are eligible to apply.
- 2) All qualifications should be from Universities/ Institutions recognized and approved in India.
- 3) All computations of experience requirement / qualification shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement. The date of declaration of result/issuance of Mark sheet shall be deemed to be the date of acquiring the qualification and there shall be no relaxation on this account. Post qualification experience on a post/ level shall be counted only from the said date onwards. Internship training shall not be counted as experience.
- 4) Candidates claiming to belong to any particular category shall necessarily submit a copy of EWS/OBC/SC/ST/PwBD certificate, as the case may be, from a Competent Authority.
